MOTIF / REASON:

CCS admite contestatia depusa de reprezentantul clubului CRG Romania cu privire la aplicarea regulamentului tehnic. In urma verificarilor tabelului cu greutatea de la sfarsitul Mansei Finale 2, CCS constata ca cele doua valori notate in tabel sunt 144.8 kg, respectiv 144.8 kg.

Avand in vedere ca CCS nu a primit niciun raport din partea delegatului tehnic la momentul respectiv, CCS noteaza ca in lipsa acestui document, nu s-a putut aplica o penalizare conform regulamentului tehnic.

Avand in vedere analiza acestor documente, CCS concluzioneaza ca regulamentul tehnic nu a fost respectat cu privire la greutatea minima. Astfel, CCS decide penalizarea concurrentului 301 pentru greutatea minima neconforma, asa cum scrie in regulamentul disciplinar: neincadrarea in prevederile regulamentului tehnic depistata in orice moment al concursului atrage descalificarea din mansa respectivă conform art. 6.20 din R.D
