**MOTIF / REASON:**

The Driver no. 68 received mechanic's assistance after 3 min-signal in assembly area. The mechanic of kart no 68 uses a screwdriver to tighten something near the airbox. This fact (reported by Mr. Ross Upton - Judge of Fact in the Pre-grid) is a violation against art. 2.19. F of the CIK-FIA General Prescriptions.

The Stewards impose this penalty according to Art.2.24 and Art.12.3 of the 2022 FIA International Sporting Code.  
The Competitor is reminded of his right to appeal in accordance with Article 15 of the 2022 FIA International Sporting Code however according Art.12.2.3 of the 2022 International Sporting Code the possible appeal shouldn't have any suspensive affect.
