**MOTIF / REASON:**

The Driver caused a avoidable collision/accident in the lap 3. He weaves aggressively trying to remove kart no 251 from the rear bumper in front of multiple karts, causing to collide and a kart to retire (reported Race Control after request of Race Director). After hearing the Entrant concerned, the Stewards judge this action as dangerous behavior. This disregarding of Code of Driving Conduct is penalised with this Decision in accordance with art. 12.2 and 12.3 FIA International Sporting Code.

The Stewards impose this penalty according to Art.2.24 and Art.12.3 of the 2022 FIA International Sporting Code.

The Competitor is reminded of his right to appeal in accordance with Article 15 of the 2022 FIA International Sporting Code however according Art.12.2.3 of the 2022 International Sporting Code the possible appeal shouldn't have any suspensive affect.
