_The above-mentioned Driver caused an avoidable collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.
In the session concerned by MP 2 made contact with kart n° 264 and following of this manoeuvre Driver n° 264 lost the position.
_ This fact is a violation against the Art. 3.6.2 b of the 2023 FIA International Sporting Code of Driving Conduct.
_The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.
_The Competitor is reminded that, in accordance with Art. 25 of the 2023 CIK Specific Prescription, the above penalty is not susceptible to appeal.
