The Stewards having received 3 reports from the Judge of Facts (Doc n° 68 - 69 - 70) requested by the Race Director, having examined this report, summoned and heard the Driver and Entrant concerned (Summon Doc n° 126), have considered the following matter, determine the following:  
\_The above-mentioned Driver caused a collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.  
\_In the session concerned by MP 2 and 8 made the contacts with the karts n° 6 - 57 - 58 and following of this manoeuvres the kart no. 6 - 57 - 58 lost position.  
\_This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.  
\_The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.  
\_The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2023 FIA International Sporting Code and Art. 10.1.1 of the 2023 FIA Judicial and Disciplinary Rules, within the applicable time limits.
