MOTIF / REASON:

The Stewards having received a report from the Judge of Facts (Doc n° 79 - 81) requested by the Race Director, having examined this report, summoned and heard the Driver and Entrant concerned (Summon Doc n° 141), have considered the following matter, determine the following:

The above-mentioned Driver caused an collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.

In the session concerned by MP 2 made contact with kart no. 326 and following of this manoeuvre kart no. 326 lost the position. At MP 2/3 made contact with kart no. 236 and kart 236 had to retire.

This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.

The Stewards impose this penalty according to Art. 2.24 of the 2023 CIK-FIA General Prescriptions and Art. 12.4 of the 2023 FIA International Sporting Code.

The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2023 FIA International Sporting Code and Art. 10.1.1 of the 2023 FIA Judicial and Disciplinary Rules, within the applicable time limits.
