5 sec time penalty in the above-mentioned Session. \_1 points on the Digital Licence.

#### MOTIF / REASON:

The Stewards having received a report from the Judge of Facts (Doc n°111.) requested by the Race Director, having examined this report, summoned and heard the Driver and Entrant concerned (Summon Doc n°183.), have considered the following matter, determine the following:

\_The above-mentioned Driver caused an avoidable collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.

In the session concerned in lap8 by MP 2 he hit the kart (kart n°55) and following of this manoeuvre Driver n° 55 lost positions.

\_This fact is a violation against the Art. 3.6.2 b of the 2023 FIA International Sporting Code of Driving Conduct.

\_The Stewards impose this penalty according to Art. 2.24 of the 2023 CIK-FIA General Prescriptions and Art. 12.4 of the 2023 FIA International Sporting Code.

\_The Competitor is reminded that, in accordance with Art. 25 of the 2023 CIK Specific Prescription, the above penalty is not susceptible to appeal.
