\_ This fact is a violation against the Art. 3.6.2 b of the 2023 FIA International Sporting Code of Driving Conduct.

\_The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.

\_The Competitor is reminded that, in accordance with Art. 25 of the 2023 CIK Specific Prescription, the above penalty is not susceptible to appeal.
