_The above-mentioned Driver caused a collision with kart no. 51 during Lap 5 at MP 8. Kart no. 51 lost the position.
_This fact is a violation against the Art. 3.6.2. e of the 2023 FIA International Sporting Code of Driving Conduct.
_The Stewards impose this penalty according to Art. 3.6.2.e of the 2023 International Sporting Code of Driving Conduct and Art. 2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.
The Competitor is reminded that, in accordance with Art. 25 of the 2023 CIK Specific Prescription, the above penalty is not susceptible to appeal.
