5 sec time penalty in the above-mentioned Session. 1 points on the Digital Licence.

MOTIF / REASON:

The Stewards having received a report from the Judge of Facts (Doc n°172) requested by the Race Director, having examined this report, summoned and heard the Driver and Entrant concerned (Summon Doc n°.290.), have considered the following matter, determine the following:

_The above-mentioned Driver caused an avoidable collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions In the session concerned in lap 1 by MP 2 he hit the kart (kart n° 207) and following of this manoeuvre Driver n° 207 lost positions.

This fact is a violation against the Art. 3.6.2 b of the 2023 FIA International Sporting Code of Driving Conduct.

The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.

The Competitor is reminded that, in accordance with Art. 25 of the 2023 CIK Specific Prescription, the above penalty is not susceptible to appeal.
