_This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.

_The Stewards impose this penalty according to Art. 2.24 of the 2023 CIK-FIA General Prescriptions and Art. 12.4 of the 2023 FIA International Sporting Code.

_The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2023 FIA International Sporting Code and Art. 10.1.1 of the 2023 FIA Judicial and Disciplinary Rules within the annificiable time limits
