The Stewards having received a report from the Judge of Facts (Doc n° 8) requested by the Race Director, having examined this report, summoned and heard the Driver and Entrant concerned (Summon Doc n° 45), have considered the following matter, determine the following.

The above-mentioned Driver caused an collision — an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.

In the session concerned by MP 5 Kart n. 261 made contact with kart n. 303 and following of this manoeuvre both kart to retire.

This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.

The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.
