The above-mentioned Driver caused an collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.

In the session concerned by MP 3 made contact kart no 213 and following of this manoeuvre kartno 213 had to retire.

This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.

The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.
