_The above-mentioned Driver caused an collision – an incident as defined in Art. 2.24 of the 2023 CIK-FIA General Prescriptions.

In the session concerned by Lap 11 MP 3 made contact with kart n° 33 and following of this manoeuvre kart no 33 had to retire.

_This fact is a violation against the Art. 3.6.2 b of the 2023 FIA Code of Driving Conduct.

_The Stewards impose this penalty according to Art.2.24 of the 2023 CIK-FIA General Prescriptions and Art.12.4 of the 2023 FIA International Sporting Code.

_The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2023 FIA International Sporting Code and Art. 10.1.1 of the 2023 FIA Judicial and Disciplinary within the applicable time limits
