MOTIF / REASON:

The Stewards having received a report from the Judge of Facts (Doc n° 73) requested by the Race Director, having examined this report, summoned and heard the Driver and Competitor concerned (Summon Doc n° 121), have considered the following matter, determine the following:  
The above-mentioned Driver didn't respect the Track Limits to overtake another Driver and re-joined the track with advantage.  
This fact is a violation against Art. 3.6.2.b & Art. 3.6.2.c of the CIK FIA 2024 International Code of Driving Conduct and Art. 2.14. of the CIK FIA 2024 General Prescriptions.  
The Stewards impose this penalty according to Art. 2.24 of the CIK FIA 2024 General Prescriptions and Art. 12.4 of the 2024 FIA International Sporting Code.  
The Competitor is reminded that, in accordance with Art. 12.3.4 of the 2024 FIA International Sporting Code and Art. 25 of the CIK FIA 2024 Specific Prescriptions, the above penalty is not susceptible to appeal.
