The above-mentioned Driver caused an avoidable collision – an incident as defined in Art. 2.24 of the CIK FIA 2024 General Prescriptions.

In the session concerned in lap 8 by MP 9 he hit the kart (kart n°52) and following of this manoeuvre Driver n° 52 lost positions.

This fact is a violation against the Art. 3.6.2 b of the 2024 FIA International Sporting Code of Driving Conduct.

The Stewards impose this penalty according to Art.2.24 of the CIK FIA 2024 General Prescriptions and Art.12.4 of the 2024 FIA International Sporting Code.

The Competitor is reminded that, in accordance with Art. 26 of the 2024 CIK Specific Prescription, the above penalty is not susceptible to appeal.
