The Stewards having received a report from the Judge of Facts (Doc n° 34) requested by the Race Director, having examined this report, summoned and heard the Driver and Competitor concerned (Summon Doc n° 44), have considered the following matter, determine the following: \_The above-mentioned Driver caused an collision – an incident as defined in Art. 2.24 of the 2025 CIK-FIA General Prescriptions. In the session concerned by lap 3 at the Start/ Finish line made contact with kart (kart n° 244) and following of this manoeuvre both karts had to retire. \_This fact is a violation against the Art. 3.6.2 e of the 2025 FIA Code of Driving Conduct. \_The Stewards impose this penalty according to Art.2.24 of the 2025 CIK-FIA General Prescriptions and Art.12.4 of the 2025 FIA International Sporting Code. \_The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2025 FIA International Sporting Code, within the applicable time limits.
