The Stewards having received a report from the Judge of Fact (Doc no 14) stating that the Driver mentioned above overtook another driver near T9 during the Session mentioned above while Yellow Flags were shown at this Turn and marshals where on track performing an intervention.

After reviewing the evidence, hearing from the Driver and the Entrant's representative, the Stewards have decided that the Driver failed to follow the signals from Race Control/Clerk of the Course and failed to respect Art. 9.6 of the 2025 BNL Karting Series Sporting Regulations, Art. 3.6.1 of the 2025 CIK-FIA Code of Driving Conduct, Art. 2.15 of the 2025 CIK-FIA General Prescriptions, Art. 2.5 Appendix H of the 2025 FIA International Sporting Code.

And take their decision according to Art. 3.6.1 of the 2025 CIK-FIA Code of Driving Conduct and Art. 12.3 & 12.4 of the 2025 FIA International Sporting Code.
