### MOTIF / REASON:

The Stewards having received a report from the Judge of Fact (Doc no 23) stating that the Driver mentioned above overtook driver 218 near MP 4 during the Session mentioned above while Yellow Flags and/or Slow Procedure was shown at this MP

After reviewing the evidence, hearing from the Driver and the Entrant's representative, the Stewards have decided that the Driver failed to follow the signals from Race Control/Clerk of the Course and failed to respect Art. 9.3 of the 2025 RMC Golden Trophy Sporting Regulations, Art. 3.6.1 of the 2025 CIK-FIA Code of Driving Conduct, Art. 2.15 of the 2025 CIK-FIA General Prescriptions, Art. 2.5 Appendix H of the 2025 FIA International Sporting Code.

And take their decision according to Art. 3.6.1 of the 2025 CIK-FIA Code of Driving Conduct and Art. 12.3 & 12.4 of the 2025 FIA International Sporting Code

The Competitor is reminded that, in accordance with Art. 12.3.4 of the 2025 Sporting Code, the above penalty is not susceptible to appeal
