Disqualification from the above-mentioned Session.

MOTIF / REASON:

The Stewards having received a report from the Judge of Facts (Doc n° 30) requested by the Race Director, having examined this report, summoned the Driver and Entrant concerned (Summon Doc n° 34). The Driver and Competitor did not come to the Stewards. Summoned at 14:55, have considered the following matter, determine the following:
_The above-mentioned Driver caused an avoidable collision – an incident as defined in Art. 2.24 of the 2026 CIK-FIA General Prescriptions.
In the session concerned by MP 4 he hit the kart (kart n° 413) and following of this manoeuvre both karts had to retire.
_This fact is a violation against the Art. 3.6.2 b of the 2026 FIA Code of Driving Conduct.
_The Stewards impose this penalty according to Art.2.24 of the 2026 CIK-FIA General Prescriptions and Art.12.4 of the 2026 FIA International Sporting Code.
_The Competitor is reminded of his right to appeal in accordance with Art. 15 of the 2026 FIA International Sporting Code, within the applicable time limits.
